2. Competence

In the Republic of Austria decisions on the admission to studies, the recognition of examinations, and the recognition of final diplomas (validation) are taken by the organs of

the universities, the Fachhochschule Council, the Fachhochschulen or the Fachhochschule programmes, respectively.

In the Republic of Armenia decisions on the admission to study programmes are taken on the basis of the documents (*Atestat, Diploma*) which have been delivered by a publicly accredited institution, as well as the results of the admission examinations.

5. Recognition of qualifications giving access to higher education

An Austrian secondary school leaving certificate (Reifezeugnis) and a secondary school leaving certificate issued in the Republic of Armenia (General (full) secondary education Certificate) are mutually recognized as equivalent educational qualifications for the purpose of access to all kinds of higher education programmes, provided that they have

been delivered on the basis of twelve years of schooling. On the contrary, the necessary additional examinations should be required.

Applicants of the relevant other country have, as a rule, to prove the knowledge of the relevant language of teaching (in the Republic of Austria: German, in the Republic of Armenia: Armenian).

6. Recognition of examinations

The recognition of examinations should take place on the basis of a case-by-case decision taken by the competent authority, due to the existing equivalence.

7. Recognition of higher education qualifications

The following correspondences of final diplomas are recommended, in that the assessment and recognition is up to the receiving institution on the basis of the relevant curricula:
